**Entry Fees:** \$15 for extra dressage test \$35 per combined test \$30 for Gambler's Choice  
\$30 per rider for Hunter Pair \$65 per horse trial \$25 for stall

**Awards:** There will be a JR and SR division for all combined test and horse trials. Ribbons will be awarded for 1<sup>st</sup> to 6<sup>th</sup> place for both JR and SR divisions in each level. Ribbons will not be awarded for extra dressage test. Hunter Pairs will be required to run the cross country course in order, best performers will win ribbons.

**Closing Date:** On desk Thurs, April 12th **Ride Times Available:** Friday, April 13th after 3:00 PM – posted and email

**Rules:** USEF rules will be followed to biting, saddlery, and use of tie downs. Riders must wear hard hats and footwear with heels. In addition, vests must be worn by all riders on the cross-country course. The 2011 Intro A Dressage Test will be used for the green as grass and starter divisions; 2010 USEA test "A" will be used for the all other divisions.

**HUNTER PAIRS: \$30 per rider.** Run the course together in order. Point system: 5 pts each GAG jump, 10 pts each starter jump, 20 pts each BN jump, and 30 pts each N jump. Additional 10 pts given for each jump done at the same time. Refused jumps will have a deduction of 20 pts. In the event of a tie, time penalties will be given. This is a good confidence builder for a beginner rider or a rider that wants to try some more difficult jumps. The experienced rider leads the less experienced rider through the course.

### **GAMBLERS CHOICE: \$30 Each**

You can ride cross country, and pick and choose any of the jumps- any order, any height. Not judged.

10 Permanent Stalls available and some temporary stalls. Stalls will not be guaranteed until payment is received. Stalls \$25 each.

*Show management reserves the right to change ride times when deemed necessary to facilitate timely completion of the show. Entries must be received by closing date at 5:00 p.m. Late entries may be refused or charged a late fee of \$20 at the discretion of show management. If cancellations are necessary, a full refund will be made if the show manager is notified before closing date. All fees must be paid by the closing date unless prior arrangement is made with the show manager. In such case all fees will be due before entering the arena. After closing date, refunds will be made only with a doctor or veterinarian certificate, less \$10 office fee. All no-show entries will be billed to the rider.*
